**Committee on Appointment, Promotion, and Advancement (CAPA)** – John Gallwey, Affiliated Representative

### 1. Review Process

In 2006/07 CAPA reviewed fifty-eight merit/promotion review dossiers, including seventeen from affiliated librarians. Seven candidates sought career status, and seven sought promotion. Eight requests for accelerated merit reviews were received. Four Ad Hoc Committees were appointed to work on the career status and promotion cases.

All dossiers came in on time, and the quality of the dossiers was generally high. CAPA reviewed Distinguished Status cases for the first time since the introduction of the new salary scale in July 2000.

## Committee on Affiliated Library Affairs (CALA) - Susan Garbarino, Chair (2006-2007)

I attended the Fall 2006 and Spring 2007 LAUC Assemblies as a delegate of LAUC-B. The topic of discussion at the Fall Assembly was "Repositioning the UC Libraries as a Destination Place" discussing recruitment and retention of UC librarians.

As CALA chair, I organized the Fall and Spring Affiliated Library Assemblies. The speaker at the Fall Assembly was Dr. Whitney Davis, Chair of the UCB Academic Senate Library Committee who spoke on library space issues, digitization and support for librarian professional development. The speaker at the Spring Assembly was Robin Chandler, Director of Data Acquisitions, Mass Digitization at the California Digital Library, who spoke about current mass digitization projects at UC. The Library Human Resources Department is making progress on remapping Library Assistant positions under the new Career Compass framework. Until the remapping is complete, LHRD cannot accept reclassification requests into LA V or LA–Supervisor positions. It was previously announced that this reclass "pause" would end on July 1, 2008, but this timeline may be revised. # Professional Development Committee – Seyem Petrites, Affiliated Representative

The Professional Development Committee met in September for the traditional "turn over" meeting as well as to discuss ideas for programs for the new academic year. It was agreed that an email asking for suggestions for potential programs would be sent to LAUC-B members.

On October 2, the Committee hosted the annual Academic Review Program for LAUC-B members. Representatives from CAPA, LHRD, Academic Personnel, as well as Tom Leonard, University Librarian, were on hand to conduct discussions and answer questions. Over 50 people attended the meeting, and the consensus was that the program was very helpful for everyone and especially for those who are pursuing reviews in this cycle.

## TALAG (The Affiliated Libraries Administrative Group) - Nick Robinson, Chair

TALAG meets quarterly. There have been two meetings (June and September) since the last Affiliated Assembly.

The TALAG chair attends Roundtable and sends brief summary reports to TALAG after each meeting.

In partnership with The Library and LAUC-B, TALAG submitted a successful proposal to the Berkeley Initiative for Leadership on Diversity (BILD). The project will include a staff development mentoring initiative, and a Library Diversity Fellow Program. All Affiliated Library employees are included as participants in this project.

The TALAG Chair met with Bernie Hurley to discuss the Affiliated Libraries involvement in planning for a new UCB Integrated Library System (ILS). The Library will include input from the Affiliated Libraries during the RFP process for selecting an ILS vendor.

Representatives from TALAG met with Ivy Anderson, Director of Collection Development at CDL, and discussed opportunities for Affiliated Libraries to participate in a variety of CDL initiatives, including mass digitization, digital preservation, licensing of electronic resources, and the Shared Cataloging Program.

TALAG consulted on the formation of the Affil-Tech group, and supported the concept of developing an NRLF Best Practices Manual.

TALAG held its annual meeting with Tom Leonard, Isabel Stirling, and Bernie Hurley. Discussion centered on collaborations between The Library and affiliated libraries, the UC/OCLC Local WorldCat pilot project, and the New Directions initiative.
