### ANSI/NISO Z39.71-2006 (R2011) Holdings Statements for Bibliographic Items

- A change in UC Berkeley practice for recording holdings statements in fields 866-868 in Alma holdings records
- Peer-reviewed national standard
- First approved in 1999, revision approved in 2006 and reaffirmed in 2011
- Promotes consistency in the communication and exchange of holdings information

### **Moving forward**

- Effective April 4:
  - When **creating a new** holdings statement, use the NISO standard
  - When **updating an existing** holdings statement, either:
    - Update the holdings statement to use the NISO standard
    - Update the holdings statement according to the existing pattern
  - If no edits are required, accept legacy holdings statements; do not update existing holding statements just to follow the NISO standard
  - Do not mix legacy practices with the NISO standard
